The applicant must have successfully completed the examinations set or approved by the Council. <ol style="list-style-type: none"> 2.1 The applicant must have successfully completed a jurisprudence examination set or approved by the Council. 3. The applicant must have engaged in clinical practice for a total of at least three months during the two years immediately preceding the date of the application. 4. Where, in the opinion of the Registration Committee, the program that the applicant completed is deficient in one or more aspects, the applicant must give a written undertaking to the College whereby he or she agrees to abide by any terms, conditions and limitations imposed by the Registration Committee on his or her certificate of registration until the applicant meets the educational requirements set by the Registration Committee. 5. The applicant must be a Canadian citizen or a

permanent resident of Canada or authorized under the *Immigration and Refugee Protection Act* (Canada) to practise the profession in Canada. O. Reg. 830/93, s. 4 (1); O. Reg. 92/12, s. 2.
